A Special Board of Education Meeting was held on Wednesday, July 9, 2008, in the training/conference room. Present were: Board Chair, William MacDonald; Secretary, Nadine Bell; Board Members Charles McMonigle, Catherine Vargas, Frank Morse, Raffaella Calciano-Coler; Maria Mennella; and Superintendent, Jeffrey A. Villar. The meeting was called to order at 6:06 p.m.

Executive Session

Catherine Vargas moved to go into Executive Session; Nadine Bell seconded the motion. The motion passed unanimously.
